Honeymoon Lodge Proposed for Steelhead Area

A project to erect first units of a Honeymoon Lodge on a forty-acre site on Dewdney Trunk Road near Steelhead was submitted to Municipal Council on Wednesday evening.

Proprietor of Hoyer's Reception Hall and Studio, Kingsway, Burnaby, said he had started clearing the site but wished council approval before building on it.

He had in mind, he said, a two-storey main building of 20 rooms with lounge and dining room, eventually a number of cabins, swimming pool or small lake and riding trails on the property. One storey of the building, to contain 10 units, might be built first.

There was a need, he said, for a moderate-priced, quiet and well run lodge for newly-married couples who could not afford the rates of the larger resorts.
